Moreover, prevention and suppression of corruption in the private sector is also one of our main policies in the future, therefore, we will strengthen the promotion of the new law and establish task force for combating corruption in commercial activities in order to create a fair and just business environment.

On the other hand, to keep up the pace of globalization of Macao, the CCAC will adopt measures to further the cooperation and connection with relevant agencies of neighboring countries and regions to fight corruption.
